

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020

## **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.


Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Delete the reference to the OP1 site in Crimmond in its entirety from Table : 3 Housing Allocations in the Riural HMA and from the settlement statement

#### Reason for change:

This site entered the audit in 1995 and has been logged as a long term constrained site for some years now. It is constrained on ownership and marketability grounds and the Planning Authority has given no timescale for the removal of those constraints in Appendix 4 of the 2019 housing land audit.

It has appeared in four previous local plans and has failed to deliver a single house in any of the various plan periods it has supposed to contribute to meeting the strategic allowances.

It is an arbitrary allocation which pays no regard to field boundaries or the adjacent built development and has attracted no planning applications over the past 26 years.

Recruiting allocations for inclusion in yet another LDP from the long term constrained land supply shows a complete disregard for the provisions of SPP. There is absolutely no basis to support the confidence that this site will now deliver housing necessary to satisfy SPP.
