



PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.


This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Delete the contribution of 5 houses to the Allowances 2020-2032 from the OP1 site in Fordyce. Identify an alternative effective allocation in the Local Growth Area of the Rural HMSA or, if marketability constraints preclude the identification of such an allocation, in the Local Growth Area of the Aberdeen HMA where marketability constraints are not an issue.

Reason for change:

The OP1 site entered the audit in 2004 as an allocation in the Aberdeenshire Local Plan : 2006. The site was then, as now, in the ownership of Seafeld Estates.

In the 2019 housing land audit the site is indicated as marketability constrained. However, the site owner has not attempted to promote the site by means of a planning application at any point in the past 16 years.

The assertion that the site is now being marketed by the owner is irrelevant and does not warrant the entry of the site as contributing to meeting the strategic allowances for the 2020 - 2032 period. The site formed part of the established supply on the 1st January 2019 and cannot be misrepresented as qualifying new allocation.
