PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.


This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Delete the contribution of the OP2 allocation in Cairnbulg / Inverallochy to meeting the strategic allowances from Table 3 of Appendix 6. Identify an alternative allocation in the Local Growth Area of the RHMA or, if marketability constraints preclude the identification of an alternative allocation, in the Local Growth Area of the adjacent Aberdeen HMA.

Reason for change:

The OP2 site was a windfall site and not an allocation having entered the housing land audit in 2019 without being subject to the LDP public consultation procedure.

As a windfall site entering the audit in 2019 it is included in the existing effective land supply and cannot therefore score against the strategic allowances. The reference to 6 houses counting against the allowances is erroneous as only 3 additional houses have been approved beyond the 37 in the audit in 2019.
