

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

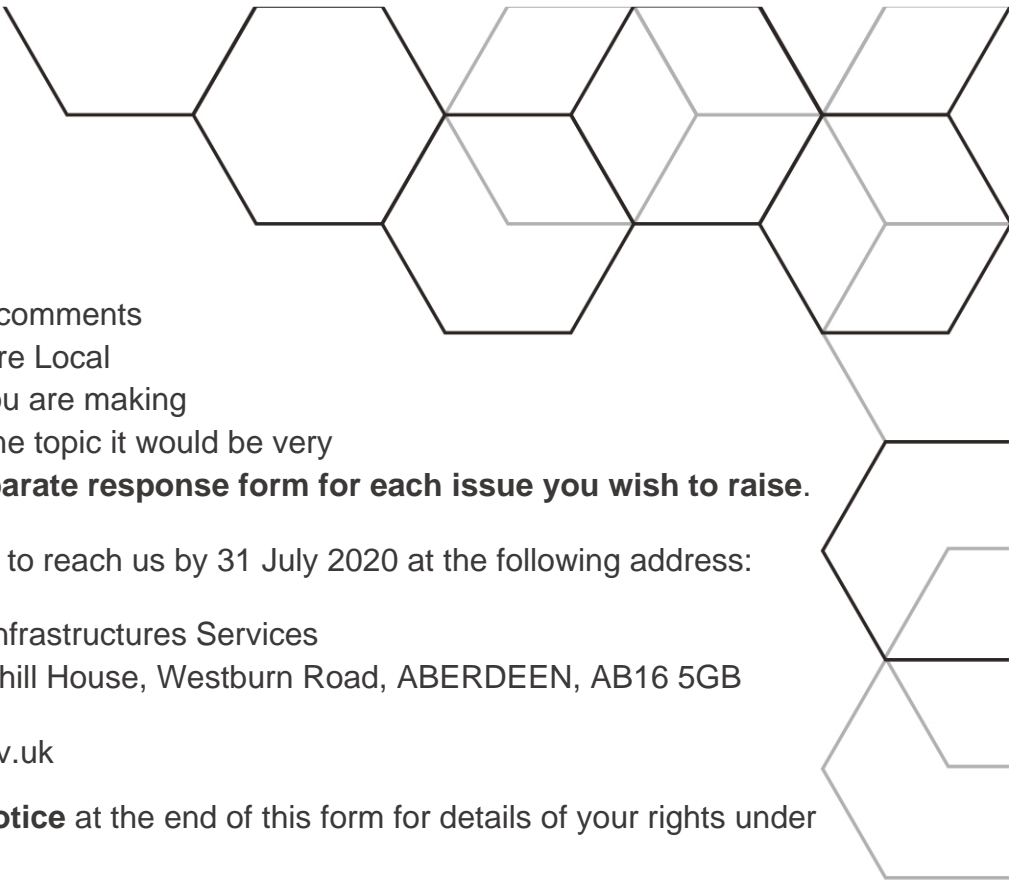

I wish to object to the proposed local development plan for the changes in Potterton. The proposed LDP would open up mass development in the village which I don't want for a variety of reasons. I object to OP1, OP2 and the destruction of greenbelt areas

**Reason for change:**

Inappropriate use of greenbelt due to existing more suitable areas that could be used avoiding an unjustifiable loss of greenbelt land in the area.

As a regular visitor to the local ancient woodlands on an almost daily basis, these need to be protected from development.

We also have children of school age and the provision in the area is already stretched and due to be at 118% capacity in 3 to 5 years. Therefore, these developments on the proposed sites and scale would overload this critical system.

There has also been virtually zero community engagement and it feels as if Covid19 is being used as an excuse to push through these plans. At the very least, the plans should be sidelined until such time that genuine public consultation can go ahead.

Potterton is a rural village, there is a complete lack of infrastructure to support such development with road safety already a major concern without the loading this development would have. This would include approximately 300+ additional vehicles in the village with no upgrading to trunk roads surrounding the area.
