PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Appendix 7f – Marr Settlement Statements - Inchmarlo

Amend the new boundary and wording of designation P1 to retain the boundary and wording contained within the adopted Local Development Plan's P1 designation.

Reason for change:

Designation P1 has been a long-standing feature of the Settlement Statement for Inchmarlo over the existing and previous iterations of the Development Plan. Its role within the currently adopted Local Development Plan (LDP) is stated as being to "conserve the setting of Inchmarlo House" and extended to cover the setting of the principal elevation of this listed building, including the parkland area to its south.

The Proposed LDP 2 boundary of P1 has been extended considerably and now extends to cover the majority of woodland within the Inchmarlo Estate, including trees surrounding the less important elevations of Inchmarlo House. The stated purpose of this designation is now to "protect the setting of Inchmarlo House as a contribution to the character of the place including specimen trees that form a characteristic element of local design".

No adequate need or justification for this extended role of designation P1 has been provided by the Council and it now appears to be seeking to form a further and unnecessary form of policy role than its original purpose to preserve the setting of Inchmarlo House.

The value of the internal landscape and vegetation of the Inchmarlo Estate is already well appreciated and protected, with a key reason for the required preparation of the existing Inchmarlo Continuing Care Retirement Community Masterplan Report (approved by the Council in April 2015) being to ensure appropriate development can be provided while respecting the setting of Inchmarlo.

There are already a large number of individual and group tree protection orders (TPOs) within Inchmarlo and identification of areas of established woodland. Existing policies HE1, P3, PR1.7-8 already provide adequate protection to the setting of listed buildings, woodland and the character of an area.

As such, there is no justified need or purpose for this extended boundary and role of designation P1 and so we request that its boundary and wording be reverted to that within LDP1.
