# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



## **Appendix 7f – Marr Settlement Statements - Inchmarlo**

Remove proposed new designation P2.

### **Reason for change:**

No adequate reason for the inclusion of this new protected policy P2 has been provided by the Council and it is considered by the Respondent that this new P2 designation is unnecessary and that its role and wording is too vague to ensure appropriate and consistent use as a policy tool.

The Respondent considers that this additional layer of policy protection is not necessary and that the general policies of E2, PR1.6 are sufficient to protect the continued use of the 9 hole golf course area in the future. There are existing policy provisions to ensure active sports uses are not lost to development pressure.

The relationship between the 9 hole golf course and its adjacent setting of the Inchmarlo Continuing Care Retirement Community (ICCRC) has not changed since the adoption of the current Local Development Plan – which did not include a separate policy protection for that area. There is potential for the vague wording of this policy to conflict with other policy provisions, such as the delivery of development sites in the adjacent ICCRC which are included within the existing Inchmarlo Continuing Care Retirement Community Masterplan Report (approved by the Council in April 2015).
