PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



YOUR COMMENTS

Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

GreenPower recommends that the Aberdeenshire Proposed LDP is amended to reflect national Climate Change policy and the likely policy position of the emerging NPF4. This presents an opportunity for Aberdeenshire Council to align itself with targets on climate change and emissions and provide a sound basis for sustainable development and economic recovery post Covid-19. The Landscape Capacity Study is fundamentally flawed and significantly out of date and out of tune with public opinion which is strongly supportive of onshore wind development. It would be helpful if the LDP made it clear that the LCS will not be relied upon to determine acceptability of specific project proposals. There are many inconsistencies in the LDP and it does not appear to GreenPower to be fit for purpose in its current state and should be significantly amended.

Therefore GreenPower formally objects to the LDP and would encourage Aberdeenshire Council to be much more positive and flexible in its approach to enable renewable energy development in the region in order to support the national effort to tackle climate change and to realise the benefits for the people and economy of Aberdeenshire from renewable energy development.

Reason for change:

The Foreword of the proposed plan offers encouragement for developers proposing renewable energy solutions for a low-carbon future, when it states at Section 2 that "New development will be sustainable. What we do and how we live today should not leave our children unable to achieve a similar quality of life in the future and should take into account the important issues of climate change and reducing carbon use."

However, whilst such encouragement is laudable, the draft LDP makes no reference to the nationally declared climate emergency, nor the Scottish Government commitment to reducing the effects of climate change through a 75% cut in emissions by 2030, and netzero greenhouse gas emissions by 2045, that requires a shift to a more supportive approach of the renewable energy technologies needed to meet the energy and climate change targets. Much has changed since the current LDP was adopted, such as the need to tackle the climate emergency, and GreenPower would like to see the proposed LDP take a much more positive approach to enable renewable energy development in meeting these targets and to the benefits that will result both for Aberdeenshire and for delivering national policy.

It is the opinion of GreenPower that the Proposed LDP should be amended to reflect the Scottish Government's climate change commitments and support for the further development of renewable energy developments, particularly at the scale required to meet our energy and climate change targets.

C2 Renewable Energy

The introduction to Section 13 describes climate change as 'possibly the greatest challenge facing the world today', and we welcome the statement at Policy 2.1 that Aberdeenshire Council will support renewable energy developments.

It is therefore highly relevant that the Proposed LDP align itself with the technologies best suited to delivering low-carbon energy, with Onshore Wind being the cheapest form of low carbon electricity generation available to the UK, as outlined in the 2018 BVG Associates report 'The Power of Onshore Wind'.

Policy C2.2 Wind Energy

GreenPower is encouraged that Aberdeenshire Council *"will approve wind energy developments in appropriate locations"*, however it is not at all clear how this will be assessed or which criteria should apply. It would be greatly preferred if policy C2.2 were amended to reflect the criteria defined in SPP.

GreenPower has substantial concerns as to the reference to the 2014 Strategic Landscape Capacity Assessment for Wind Energy. The Capacity Study – published in March 2014 – came into effect prior to the latest SPP and the subsequent declaration of the climate emergency and net-zero target for carbon emissions.

The Executive Summary of the 2014 Capacity Study states that 'the assessment has determined that there are <u>no areas of Aberdeenshire suitable for extensive windfarms</u> <u>with large turbines</u>'. This document cannot provide a suitably positive or flexible framework to assess future applications, if it has already determined there is no scope for large turbines. In any case, the use of the landscape capacity study to effectively produce another layer of SPP Group 1 'no-go' areas for turbine development is questionably at odds with SPP 2014. The resulting 'preferred areas' for onshore wind development are also questionable, for example in one of the preferred areas south of Keith the area has already had numerous applications for wind energy projects refused. The Proposed LDP also recommends that *'existing bases should be reused'* however, this does not take into account that modern commercial-scale turbines also typically require greater spacing, and so repowering like for like on a site is highly improbable, even if the bases were able to be re-used with warranties and engineering requirements met.
