PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Removal of Proposal OP1 – Land South of Earnsheugh Terrace form Appendix 7e Settlement of Statements- Kincardine & Mearns – Page 667 – Allocation of 11 homes

Reason for change:

Findon is a historic fishing village surrounded by SSSI land and is made up of a mix of fishing cottages, coastguard cottages and crofts. There are a few modern homes in the mix but a whole development scheme of 11 new houses would be totally out of place.

My objections to this proposal, relate to the road access and increases in road traffic; changing the aesthetic look and feel of the village and contradicting the existing Aberdeenshire Development plan.

There are two access roads to the village which are country roads with passing places, blind bends and no pavements which struggle already with the existing residents own vehicles, delivery traffic and commercial vehicles supplying the Survitec facility at Findon shore. I have been involved in two accidents in the past which arose from the narrow and blind roads and fear that another 11 houses with construction traffic, resident traffic and delivery would increase the risks to all the current road users.

Within the village, there are two road accesses marked to the proposed development. The one to the East serves the existing 8 houses at the lower end of Findon and has a very narrow point between two of the current houses. This road is steep and proves difficult for traffic during the winter.

The West road which serves Findon Shore has a two-vehicle access at the top. This junction has had several near accidents with large vehicles leaving and accessing Survitec. The probability of accidents would increase with the new development at the top and near to the top where there is a blind bend with a tight turn and a steep slope.

From an aesthetic and feel standpoint, Findon is a village and local residents are happy with the lack of streetlights etc and are accustomed to the lack of pavements. Allowing a significant development of 11 new houses increases the number of houses by approximately 20% and I feel this would prove unnecessary and unacceptable change to the lives of the existing residents.

I believe that the existing Aberdeenshire development plan vetoed large scale development East of the railway line as there is ample house building opportunities in Checkbar, Hillside, Newtonhill and Chapleton. Once again, 11 new houses is a significant development given the number of existing houses in Findon.

I look forward to hearing back from you and that this proposal is removed from the Local Development Plan 2020.
