

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Appendix 7c, p458, Newburgh. Discontinue plans for OP3.

**Reason for change:**

I believe that the plans to build 160 new homes and a new road would have a detrimental effect on the village of Newburgh where I live. This is a small community with limited facilities to handle a significant increase in population, particularly in relation to the local school which is currently at a high capacity and likely to increase further when a new housing development (OP2) is finalised; the school has already been struggling with its performance and recently been put into special measures, so further loading would worsen this situation.

The proposed North Distributor Road would make Knockhall Road dangerous for pedestrians as it would significantly increase traffic along this single-track country road which has almost no passing places, blind corners and blind summits. This is an extremely popular walking route for my family, adults, children, parents with prams, people in wheelchairs, dog walkers and joggers (i.e. up to the castle, loop around the back, down the proposed North Distributor Road and then through the village along the estuary). If people were to have to avoid this route because it was turned into a rat-race, or was no longer enjoyable because of cars passing at high speeds, then it would be a terrible loss to the community as it's a beautiful place to enjoy an accessible part of the quiet countryside.
