PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

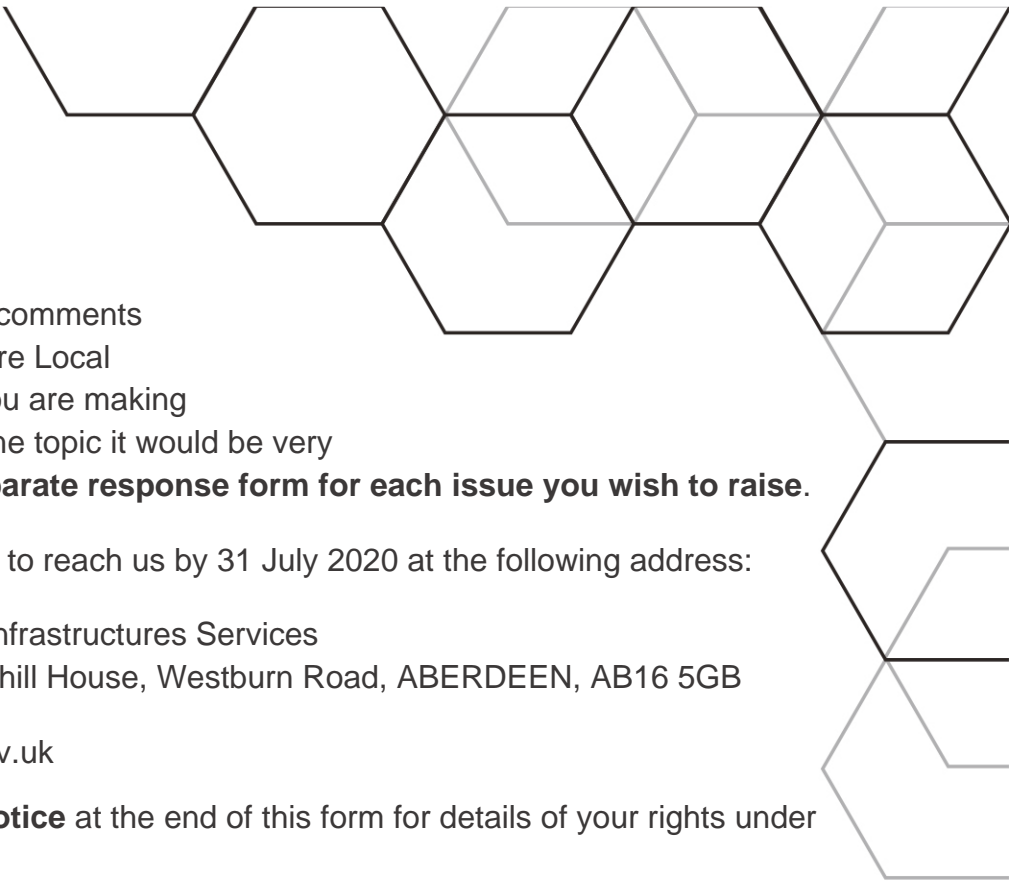

Appendix 7c pg. 458; Newburgh. North Distributor Road - discontinue plans for north distributor road.

Reason for change:

The North Distributor road is planned to widen a valuable recreational path that is heavily used by the residents of the village but in particular: children, joggers, disabled residents, parents with pushchairs and dog walkers.

The route that runs up Knockhall Road and down the proposed North Distributor road has immense value for the health and wellbeing of the village residents.

- It is a natural environment which, thanks to the established hawthorn hedgerow has a diversity of butterfly and birds which can flourish due to the low traffic passage.
- It is a safe environment that is suitable for small children to ride their bikes, young families to walk and parents with pushchairs and prams as well as dog walkers thanks to the openness of the road. Families have been walking this route in large numbers during the lockdown in particular.
- It is an accessible environment. Although Newburgh has a plethora of walking options, many are not accessible for young children, people with mobility issues, pushchairs and wheelchair users. This route is a fully tarmacked surface that is accessible straight from the doorstep of Newburgh houses and anyone can enjoy a circular walk past fields, castles, a river and dunes without having to get in the car.

The proposed route will target traffic that is mainly going between the North bound junction of the A90 (plus surrounding villages) and Cruden Bay (plus surrounding villages). While there is no dispute that this will be used it does not bypass the most used route through the village by the highest volume of traffic. The majority of traffic on the A975 is commuter traffic travelling in from Aberdeen and heading north and vice versa. We live on School Road and so are aware of the Ellon bound traffic. From my own observations of the traffic that passes our house it is just a fraction of the traffic that is travelling along Main Street. Therefore the village will not materially benefit from the appropriation of such a well used and valuable resource.
