PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Although the Site Ref noted above is not contained within the LDP proposal, I would like to state my objection for the development of a 10-13 home development on this site. With ~150 homes already proposed through OP1, OP2 & OP3 and this site being on the most northerly point of the village boundary, it does not make sense to grant further housing land in the village. I would like to propose minor extension to the village boundary as detailed in Fig 1 below.

Reason for change:

owner of the most northerly home on Bains Park, Tarves and the area of ground next to me has been unused since I moved into the property in 2013. This rough ground has now become a repository for local residents garden waste and is essentially creating a huge compost heap that becomes overgrown with weeds, mice and likely other unwanted rodents.

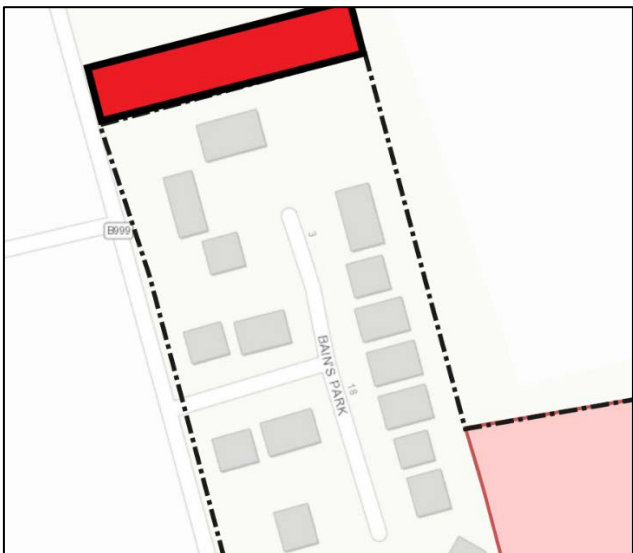

I have been considering adding a garden sunroom onto my property, consistent with other houses in the development. This would be north facing and which would reduce the space in my rear garden. As the land beyond my north garden fence is currently wasted land, I would like to propose extending the village boundary by between 10-15 metres to allow an extension of my garden. I am proposing a strip as proposed in Fig 1 above as I appreciate the it may be easier to extend boundaries in straight lines but Fig 2 shows my own requirements, and this would obviously be subject to agreeing a purchase with the land owner.
