

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

## YOUR COMMENTS

**Modification that you wish to see** (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

I object to the proposed local development plan in greenbelt areas surrounding Potterton. This would increase the village by 50% over the next 5 years which will be to the detriment of the local community. My objection is to OP1, OP2 7 the eradication of greenbelt land around Potterton

**Reason for change:**

**Inappropriate use of Greenbelt**

It is unacceptable to change the use of the land for housing that in the current climate is not needed and would have a negative affect on the local community in many ways. There has been very poor consultation & opportunities for residents to voice their concerns.

**Woodland and protected species**

In the proposed development areas there are historical interests i.e Cairns & Standing stones. Also protected species & ancient woodland. It is essential they are protected from development.

### **Lack of Community Engagement**

Covid-19 should not have been used as an excuse to prevent local residents from voicing their concerns and I question the timing of pressing the councils development plans. Why prioritise this when so many other council services were stopped due to being classed as non essential?

As a council tax paying citizen this is against our constitutional rights, at a time of unprecedented changes to our daily lives. This has only added to the anxiety/worry that local residents have had to endure.

There has also been very little opportunities for residents with no technology available to engage with the proposed plans, so therefore excluded.

### **Sewage/Lack of infrastructure**

There is insufficient capacity at Balmedie Water Treatment plant but no provision in the plan to address this.

It is also a concern that OP1 & OP2 lie within SEPA's 1 200 year Flood risk area

This has been noted in the strategic environment report that there would be water coursing during development. This would potentially affect bordering homes to the development

Scottish water are aware that there is a high water table at Potterton with ongoing issues with drainage. The pumping station already struggles to cope with this.

### **Roads and lack of infrastructure**

There has been no upgrade of local roads that are not suitable to cope with existing traffic flow. There would be a significant increase & volume of traffic travelling through the village would be detrimental to the village.

There are very real safety concerns for both road users & pedestrians with no plans to improve the road/pavement infrastructure surrounding the village.

It is also incorrect to claim Potterton has a frequent reliable bus service. 1 hourly which has a 2 hour gap between 2100 & 1100 is not frequent. There are also no direct buses to Balmedie, Dyce, Westhill & Altens which have been highlighted as benefits of the Potterton development proposal.

### **Education**

Balmedie primary & nursery are already at capacity but there is no provision to account for the increase of children of school/nursery age. It is stated it "may be considered" that is not a promise to address this issue.

At a time of great uncertainty and with many job losses across many industries I challenge the proposed development to be unnecessary and proposed without thought to the negative impact on our local community. This has personally affected my mental health & caused added worry/anxiety at a difficult period in all of our lives.

I hope that my valid concerns will be listened to & taken seriously by the development team.
