PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Page 12 paragraph 5.1 suggested modification with addition of the words in red

As well as accommodating the immediate needs of the City and its growth, we need to consider the conservation of our built and natural heritage, **including the setting of the City and the green belt buffer zone between the City and Shire**, and **more** specifically our "regeneration towns" of Banff, Macduff, Fraserburgh and Peterhead, where development opportunities may be more difficult.

Page 19 paragraph 5.13 suggested modification with addition of the words in red

The rate of growth in Chapelton has been unexpectedly slow and the local aspiration for a model town here is likely to be constrained unless significant new development land elsewhere in the corridor is restricted, **and new settlement proposals rejected at this time especially those adjacent to the City boundary on green belt land**.

Reason for change:

There is a very real concern that developments of new settlements at the edge of the City and Shire boundary (specifically Royal Devenick Park – RDP - Phase 1 or Leggart Brae as it has now been renamed) will be the start of a very significant encroachment on the Aberdeenshire green belt and destroy the setting of the City and views from the City to the South. At the same time such plans will shatter the well-intentioned and realistic aspirations of having a vibrant new town created at Chapelton.

Aberdeenshire Council has approved in its LDP a housing opportunity for 150 homes, following a bid by the developer (OP46, bid 1308). RDP Phase 1 planned for 235 units in the City and 289 units in the Shire when the developer made its bid in 2018 – the intention of the developer is, therefore, clear and it will not stop with the relatively modest allocation of 150 units, which itself raises many planning concerns, not the least of which is transport and the proposed road access to Leggart Brae via the Shire (Causeymouth road and a new spur from the south Deeside road), as well as access created from the A92.

There would need to be speed restrictions introduced on both the major trunk roads (A92 and south Deeside road) to make the proposed access routes safe, and the Causeymouth road is completely unsuitable for HGV traffic to the site. The location and topography of the site also does not lend itself to walking or cycling, meaning that the residents of the site would use cars to travel to Aberdeen, exacerbating the existing bottleneck at the pinch point of the Bridge of Dee crossing.

The remaining Phases of the RDP development would be in Aberdeenshire, with 1545 units planned in total. The proposed development of RDP has not been included in the Aberdeenshire LDP, but if the City Council approval is taken forward then this will undermine the well-reasoned development decisions of Aberdeenshire Council, which should be robustly defended throughout the remainder of the planning process.
