

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Proposed Local Development Plan 2020 – Introduction and Policies: Page 31 section 7 - Shaping Development in the Countryside

I wish the wording on Special Rural Areas to be reinstated as it was in the 2017 LDP. Please reinstate the wording 'Policy R1 Special rural areas **'Housing and employment development opportunities will be significantly restricted in the greenbelt and coastal zone to reflect the special nature of these areas. We will only allow development if it is essential and cannot be located elsewhere.'** Instead of as shown in the proposed LDP 'R1.1 Opportunities for small-scale development will be restricted in the green belt and coastal zone to reflect the special nature of these areas.'

Please also include positive wording promoting the benefits of Green Belts, rather than only framing it in terms of negative restrictions.

Reason for change:

I strongly believe in the Green Belt and that it should be preserved – there is little enough of it as it is. There is no shortage of non-green belt land available for development.

I do not believe that the Policy wording on Green Belts should be diluted in any way so I would like it to be reinstated. I think the word 'significantly' is important and must be reinstated. I believe development on the Green Belt should not be permitted and therefore the clear and unambiguous wording 'We will only allow development if it is essential and cannot be located elsewhere' should be included in the Policy. This would be in accordance with Scottish Planning Policy (Issued June 2014) which states that on the Green Belt only limited and specific development is permitted (e.g. agricultural, forestry or horticultural), or development which is deemed to be a national priority or development required to meet an established need if no other suitable site is available.

The Green Belt provides significant social and environmental benefits. It is an important resource which protects and enhances the landscape setting. In addition, it provides important benefits to people's quality of life and well-being; contributes to tackling the global climate crisis; contains agricultural land important for food production; provides havens for wildlife; promotes outdoor recreation.

The Scottish public strongly support Green Belts and think they should have increased protection from building development (source: poll carried out for the Association for the Protection of Rural Scotland in June 2017). Due to the Covid-19 crisis this support can only have increased as many more people have come to appreciate what a valuable resource our countryside is, as they have been out walking and cycling much more, and appreciating the natural world around them.

Therefore I would like you to clarify within the listed restrictions that development on Green Belt land is not acceptable, as well as to promote the many benefits of protecting, and indeed extending, the Green Belt.
