# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

## Policy C3

"C3.1 We will seek to protect carbon sinks and stores, such as woodland and high-carbon peat rich soils (defined by Scottish Natural Heritage's Carbon and Peatland map 20167 as Class 1, 2 and 5, and greater than 0.5m depth), from unacceptable disturbance or destruction.

C3.2 Development proposals that may result in the loss of, or disturbance to, peat will only be permitted if tools such as the "Carbon Calculator" demonstrate that the development will, within its lifetime, have no net negative effect on CO<sub>2</sub>.

C3.3 Removal of woodland will only be permitted if an equal area is replanted, preferably as part of the open space requirement and as part of the green-blue network in the settlement, so as to maintain the carbon balance. In the case of development in commercial woodland then compensatory planting, or exemption, in accordance with the Scottish Governments Policy on Control of Woodland Removal will be required."

**Reason for change:**

It is submitted that many wind farms will have a positive net effect on CO<sub>2</sub>. It should not be a requirement to demonstrate no net effect.

In some cases it may be beneficial to undertake habitat restoration of peat land areas rather than replanting. This policy should recognise this.
