PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.





Inverurie P19 To protect the pitches and grounds

Reason for change:

1. This was a change which came out of the blue and was put in at the last moment, with no consultation with the club. This had not been in earlier drafts and did give Inverurie Locos Works an opportunity to engage with council officers.
2. Inverurie Locos are a key sporting, cultural and financial organisation in Inverurie that is loved by many. Almost all the work involved with the club is undertaken by volunteers who give up hours and hours of their time and expertise every week. The club works with charities and last year they helped them to raise £100,000. They are a modern community club and, for example, have been delivering food parcels throughout the pandemic. It is their calm, reasoned position that they need the possibility of moving grounds. The LDP designation would prevent this.
3. Harlaw Park is the smallest ground in the Highland League and is not suitable should they achieve their ambitions of making it to the SPFL. The only asset the club has that could conceivably finance a move to a new stadium in Inverurie is the land.
4. This option was available to the club as the land had been previously designated part of the Master Plan Developed Area under the previous LDP. The new LDP changes the land's designation.

5. Nothing can be done with the land that does not meet the Council's policies and procedures should the designation revert to its 2017 status. The Council is losing no control over how this part of Inverurie develops.
6. The change of status of the land under the new LDP also devastates the value of the land for gaining bank loans. Designating the land for football renders it valueless as an asset. It could only be sold to another football club, which is inconceivable. Therefore the LDP makes the only asset the club has to borrow against worthless.
7. The Council say the new designation is to protect the land for football but, in reality it holds the club back and prevents Aberdeenshire gaining a new state of the art facility for the 21st Century. I ask that the Council engage with the Club and, remove this designation. There is a mutual interest here in improving the quality of life for the people of Inverurie. Surely this can be worked out.
