PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

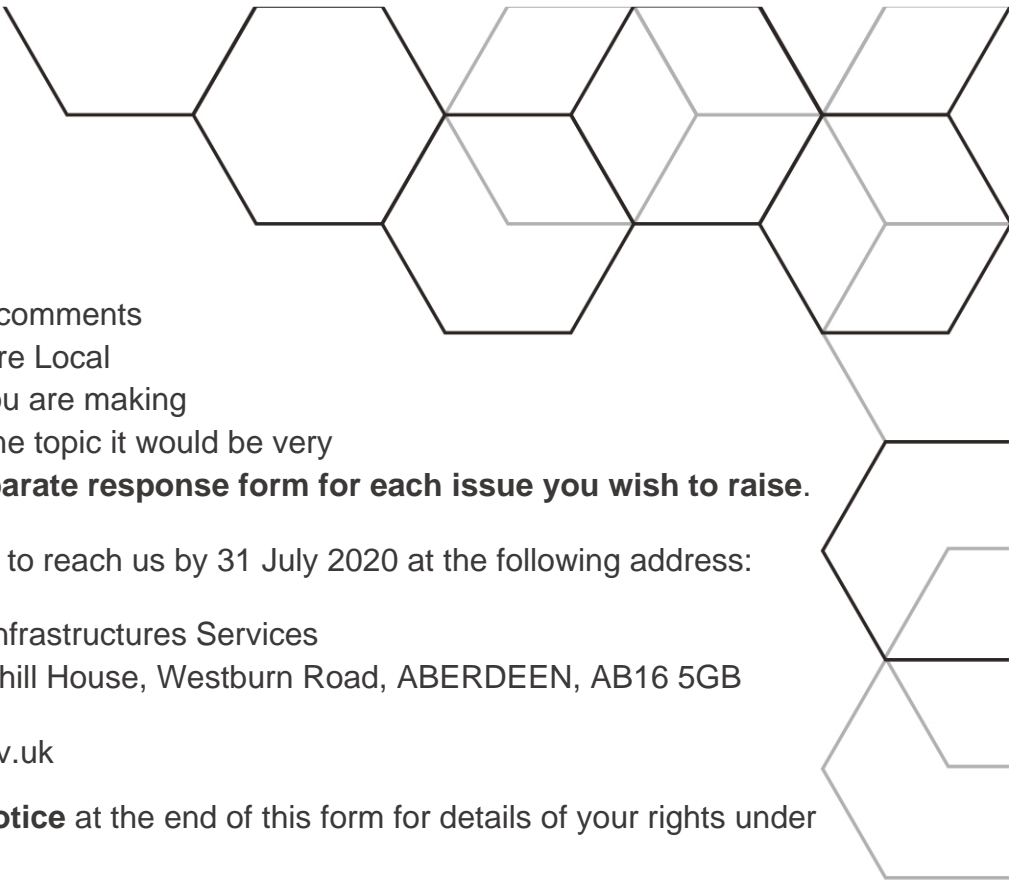

Reason for change:

From what I can gather there has been a [REDACTED] lack of transparency on the Greenbelt status of the Potterton Greenbelt by the Council, there does not appear to be any record of the process behind the decision making process to change in status nor has there been any consultation by the Council.

The Local Community Council also appear to be [REDACTED] the Greenbelt status change with again, no consultation and seem to be of the opinion that its "Potterton's time" for the development [REDACTED]

The developer has also not had any meaningful consultation with the residents of Potterton, rather they have resorted to [REDACTED] methods of garnering opinion of a very few people and using this [REDACTED] snapshot as being representative of all of the Potterton residents views.

On the basis above, I object to the LDP for Potterton in respect of OP1 & OP2 due to the [REDACTED] lack of transparency and [REDACTED] methods used to put the Development case together.
