PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Sections 5 & 8 – Spatial Strategy and Shaping Homes and Housing - The Proposed LDP should address the clear shortfall in the housing land supply identified by Homes for Scotland. Aberdeenshire Council should allocate a range of sites to help address this, as required of it by Scottish Planning Policy.

There should be a detailed review of the housing sites within the land supply to ensure they are effective or capable of becoming effective.

Reason for change:

Whilst Gladman acknowledge that the proposed Spatial Strategy for Aberdeenshire is based upon content within the Proposed Aberdeen City and Shire Strategic Development Plan 2018 (SDP) and subsequent Examination Report (2019), it is worth noting that despite the report to Scottish Ministers seeking approval in April 2020, the SDP has yet to be ratified and adopted.

There is a definite risk in preparing a Local Development Plan (LDP) based on an SDP that has not obtained formal adoption, as seen most recently when the Proposed SESplan 2 was rejected by Scottish Ministers.

As stipulated in Scottish Planning Policy (SPP) – paragraph 33, due to 5 years passing since the plan was adopted, the policies for the supply of housing are not considered to be up-to-date. Whilst SESplan could be a unique case, it is important that the PLDP acknowledges this position and does not solely rely on the Proposed SDP.

In any case, should the Proposed SDP be approved by Scottish Ministers; using the housing numbers contained within the Proposed SDP and PLDP, Aberdeenshire fails to allocate sufficient land to meet its housing land requirement.

“Table 1: Strategic Development Plan Housing and Employment Land Figures” sets out the amended housing allowances as per the Proposed SDP Examination Report. The PLDP Appendix 6 – table 1 sets out the housing allocations the Council has identified to meet the housing land allowances. The Council consider they have allocated sufficient land and in fact have a surplus of housing land. Gladman contends this position as we feel it does not accurately represent the housing land supply position in Aberdeenshire and there is in fact a shortfall in the land supply across both Housing Market Areas (HMAs) resulting in a shortfall across Authority level.

Gladman consider that the PLDP does not sufficiently ensure that existing and new allocations are effective and will be deliverable over the plan period. In line with the response provided by Homes for Scotland, it is demonstrated that many of the proposed new housing allocations are constrained within the current land supply or are part of new/larger allocations where the likelihood of them becoming effective is questioned as set out in Homes for Scotland's submission.

Gladman agree with the Homes for Scotland housing land supply position, as set out in their response to the Proposed LDP. Should this position be subject to further information requests during the Examination Process, Gladman would request the opportunity to respond.

Gladman suggests all sites contained in the housing land supply are scrutinised for effectiveness, particularly.

There is a reliance on larger housing sites to meet the housing allowances as set out in the PLDP for the period 2020-2032. In line with paragraph 119 of SPP, Aberdeenshire Council should allocate a range of effective housing sites that can be delivered in the plan period. In order to achieve this, a range of smaller housing sites, adjacent to settlements that contribute to sustainable development, will be required to augment the supply.
