PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Natural Heritage and Landscape. Section 10, page 57, Policy E1 Nature Conservation Sites, paragraph E1.3

PROPOSED LDP TEXT: For nationally designated sites a thorough assessment must demonstrate that the objectives of designation and the overall integrity of the site will not be compromised, or that any significant adverse effects on the qualities for which the site has been designated are clearly outweighed by social, environmental or economic benefits of national importance. In all cases, any impacts must be suitably mitigated.

MODIFICATION: It is suggested that the following alterations to the wording are made, with additional text in bold and text to be removed struck through:

“For nationally designated sites (**Site of Special Scientific Interest or a National Nature Reserve**) a thorough assessment must demonstrate that the objectives of **the** designation and the overall integrity of the site will not be compromised. **If adverse impacts cannot be avoided or satisfactorily mitigated, it must be demonstrated that** ~~or that~~ any significant adverse effects on the qualities for which the site has been designated are clearly outweighed by social, environmental or economic benefits of national importance. In all cases, any impacts must be suitably mitigated”.

Reason for change:

Although we welcome a policy which seeks to protect national wildlife sites, we believe that a number of changes are needed to the wording to ensure it is clear and accurate. It is crucial that the text is clear for developers, planning officers, elected members and the public.

We note that the term “nationally designated sites” is not currently included in the Glossary. We believe it should be clear in the body of the policy text what is meant by this. National designations are defined in Scottish Planning Policy (paragraph 212) as National Parks, National Scenic Area (NSA), Site of Special Scientific Interest or a National Nature Reserve. As the Cairngorms National Park Authority is subject to its own LDP and we understand that the NSA is within the CNPA, it is suggested that Site of Special Scientific Interest and National Nature Reserve are specified in the text. Alternatively, Site of Special Scientific Interest and National Nature Reserve could be listed in a footnote to define “nationally designated sites”.

In addition, we believe that that the words, “If adverse impacts cannot be avoided or satisfactorily mitigated, it must be demonstrated that”, should be included

to emphasise the need to follow the mitigation hierarchy of avoidance, mitigation and only then compensation.
