PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

PROPOSED LDP TEXT: A baseline Ecological Survey⁵ should be prepared for all major developments and for smaller proposals where there is evidence to suggest that a habitat, geological feature or species of importance may exist on the site. This evidence should be provided by a suitably qualified ecologist.

MODIFICATION: We believe that the following modification should be made, with additional text shown in bold and text to be removed scored through:

“A baseline Ecological ~~or geological~~ Survey⁵ ~~should~~ **must** be prepared for all major developments and for smaller proposals where there is evidence to suggest that a habitat, geological feature or species of importance may exist on the site. This ~~evidence~~ **baseline survey must** be provided by a suitably qualified ecologist ~~or geologist, as appropriate~~”.

Reason for change:

The current wording, and the use of “should”, means that a baseline survey is optional for major development and optional if evidence has been provided by an ecologist that a habitat, geology or species exist on site. The need for a baseline survey may be determined by the size and nature of the development and features such as watercourse, suitable nesting sites, bats roosts etc or a combination of this and a desk-based assessment. Therefore, we believe that the word “should” in the first sentence should be replaced by the word “must” to strengthen the policy and make it clear that this is not optional for major developments or sites where there is evidence of features of importance.

This wording would better support the LDPs aim to promote Aberdeenshire as “An area where natural and cultural heritage are protected and enhanced” (paragraph 3.13 of the Aberdeenshire Proposed LDP).

It is therefore appropriate to replace “evidence” with “baseline survey must” to provide a clearer and more accurate wording as this is what required a qualified person, rather than general evidence that there are species or features of importance on site.

As an ecological survey would not determine the presence of important geological features and an ecologist would be unlikely to be able to undertake a geology survey to the required standards, we have suggested that the words “geological” and “geologist” are inserted, as detailed above.
