# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

PROPOSED LDP TEXT: The following criteria may apply if development may affect the undesignated habitats or species listed in Annex I, Annex II of the EC Habitats Directive, or species listed in Annexes I and II of the EC Birds Directive.

Similar tests will apply to habitats, species on the Scottish Biodiversity List, North East Scotland Biodiversity Partnership Local Important Species, and other species of importance to biodiversity. Areas of importance to geodiversity, or seminatural habitats are also given this protection.

We will only approve: • when a baseline Ecological Survey has been carried out; • when the development has been designed to avoid impacts where possible; and • where impacts cannot reasonably be avoided, an ecological or geological management plan demonstrates public benefits that outweigh the ecological or geological value of the site and includes necessary mitigation/compensation measures.

MODIFICATION: The following criteria ~~may~~ **will** apply if development may affect the undesignated habitats or species listed in Annex I, Annex II of the EC Habitats Directive, or species listed in Annexes I and II of the EC Birds Directive.

~~Similar tests~~ **The criteria also** will apply to habitats, species on the Scottish Biodiversity List, North East Scotland Biodiversity Partnership Local Important Species, and other species of importance to biodiversity. Areas of importance to geodiversity, or seminatural habitats are also given this protection.

We will only approve **development**: • when a baseline Ecological Survey has been carried out; • when the development has been designed to avoid impacts where possible; and • where impacts cannot reasonably be avoided, an ecological or geological management plan demonstrates **acceptable mitigation and/ or compensation measures. If there are remaining adverse effects, the applicant must demonstrate that there will be** public benefits that outweigh the **impacts on the habitat, species or site.** ~~ecological or geological value of the site and includes necessary mitigation/compensation measures.~~

Reason for change:

We believe that the word “may” in the first sentence must be replaced by the word “must” to clarify that this is not optional. There is no explanation as to what circumstance it would not apply and therefore, we believe that the policy must make it clear that the criteria should always apply.

The use of the term “similar tests” is vague and ambiguous and would result in uncertainty for developers and the public. It is also the first mention of a test as the term “criteria” is used above. We therefore believe that the above suggested wording would be clearer and better protect these important sites.

Although we generally welcome the criteria listed, it would not be the remit of an ecological or geological management plan to demonstrate public benefit but rather to show how it is proposed that impacts are to be avoided, mitigated or compensated for. The mitigation hierarchy is an approach that will help to achieve ‘no net loss’ (and if possible a ‘net gain’) in biodiversity, firstly through avoidance of impacts, then if impacts can be justified, through mitigation or minimisation of impacts and finally, as a last resort, in limited circumstances, through habitat restoration or compensation. The LDP should emphasise a requirement to robustly apply this mitigation hierarchy when planning for and considering proposals for all developments

Any public benefit that the applicant wished to argue outweighed environmental impacts must be provided separately to an ecological or geological management plan. The above wording would clarify the purpose of such plans and that arguments for public benefit would be made separately.

We have suggested wording to replace, “demonstrates public benefits that outweigh the ecological or geological value of the site and includes necessary mitigation/compensation measures” as we do not believe that the value of the site (or habitats and species) can be outweighed. The section above refers to habitats, species and sites and therefore we believe it would be clearer to use these terms in the last sentence rather than just “site”. This wording would make the requirements clearer for developers and the public.
