# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

## **Section 14, page 89, Policy RD1 Providing Suitable Services, RD1.1**

PROPOSED LDP TEXT: We will only allow development that provides adequate vehicle charging (including Hydrogen Fuel Stations), road connections, waste management collections, water supply or wastewater connections and treatment as appropriate.

MODIFICATION: We believe that the words cycle storage should be added to this paragraph, as suggested below:

"We will only allow development that provides adequate vehicle charging (including Hydrogen Fuel Stations), road, **cycleway and footpath** connections, **cycle storage**, waste management collections, water supply or wastewater connections and treatment as appropriate".

### **Reason for change:**

We believe that the requirement for cycle storage, cycleway and footpath connections should be added to development requirements to ensure that provisions are made for people taking the active travel choice. This policy is marked with a bicycle symbol which we understand indicates it relates to the plans aims set out in paragraph 4.7 of the proposed LDP, "To make efficient use of the transport network, reduce the need to travel and promote walking, cycling, and public transport". However, nothing in the current wording appears to promote walking or cycling. The wording as suggested would help support active travel, reduce carbon emissions, promote healthy lifestyle and other aims of the National Performance Framework.
