# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

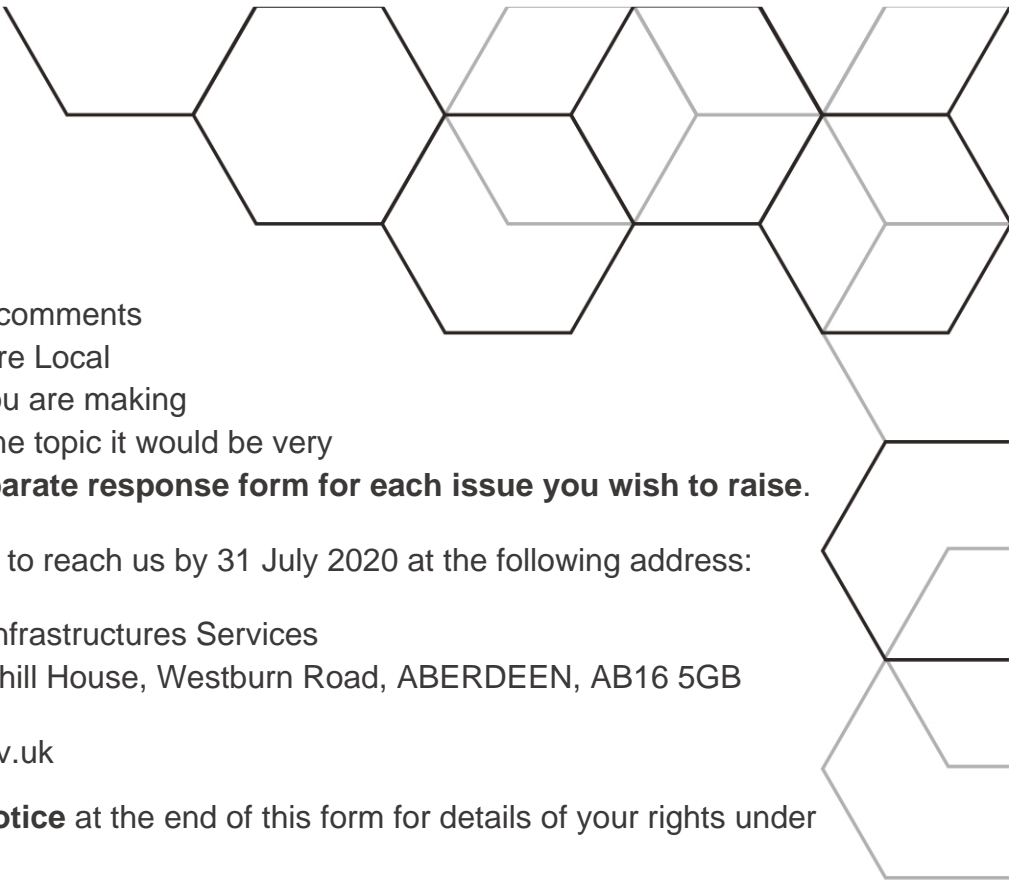

## **Section 14, page 90, Access to New Development, RD1.5**

PROPOSED LDP TEXT: All developments must include formal lit footway connections to adjacent developments that provide for access by wheelchair users, people with sensory disabilities, the elderly, those accompanied by small children and other less mobile groups. As appropriate, safe and convenient access should also be provided for service, delivery and other goods vehicles required by the development. Cycle infrastructure connections should be shown to existing and planned local and strategic active cycle routes. In particular, and where appropriate, a safe route to school should be identified and delivered.

MODIFICATION: We believed that additional words highlighted in bold should be added to paragraph RD1.5 as set out below:

All developments must include formal lit footway connections to adjacent developments that provide for access by wheelchair users, people with sensory disabilities, the elderly, those accompanied by small children and other less mobile groups. As appropriate, safe and convenient access should also be provided for service, delivery and other goods vehicles required by the development. Cycle infrastructure connections **must be provided** to existing and planned local and strategic active cycle routes **and existing cycle networks should be improved where possible**. In particular, and where appropriate, a safe route to school should be identified and delivered.

## Reason for change:

The recent pandemic has shown importance of active travel and greater emphasis must be put on the need for developers to provide these connections.

Policy RD1 is marked with a bicycle symbol which we understand indicates it relates to the plans aims set out in paragraph 4.7 of the proposed LDP, "To make efficient use of the transport network, reduce the need to travel and promote walking, cycling, and public transport". Scottish Planning Policy states that, "*Cycle routes, cycle parking and storage should be safeguarded and enhanced wherever possible*" (paragraph 288). To encourage cycling, connections must be provided in the same way that car access is required to developments and existing routes improved where possible. Therefore, we propose that the word "should" in the second last sentence is replaced by the word "must". We also believe these connections must be "provided" by the developer and not simply shown on plans. The requirement to improve existing networks would also help connect developments by active travel routes.

Cycle networks are important to deliver the aims of this proposed LDP, Scottish Planning Policy and the Outcomes of the National Performance Framework. The consideration of such networks in the original design of developments can encourage active travel, reduce carbon emissions and improve people's mental and physical health.
