PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Forward, page 8, paragraph 2, last sentence.

PROPOSED LDP TEXT: What we do and how we live today should not leave our children unable to achieve a similar quality of life in the future and should take into account the important issues of climate change, and reducing carbon use

MODIFICATION: We think that the words "biodiversity loss" should be included within paragraph 2 and the word "should" changed to "must". Suggested wordings are given below with additional words highlighted in bold and words we believe should be removed scored through:

"What we do and how we live today should not leave our children unable to achieve a similar quality of life in the future and ~~should~~ **must** take into account the important issues of climate change, **biodiversity loss** and reducing carbon use"

Reason for change:

The words “biodiversity loss” should be included in this paragraph to highlight its importance, alongside climate change, and the way that the two crises are ultimately bound together. In Scotland, 49% of species have declined in numbers, and one in nine are threatened with extinction from Great Britain¹.

The importance of the tackling the problem of biodiversity loss has been recognised at a national level. In a letter to Scottish Environment LINK July 2019 Nicola Sturgeon also stated that “The challenges facing biodiversity are as important as the challenge of climate change, and I want Scotland to be leading the way in our response.”²

In September 2019, the Scottish Government published its 2019-2020 Programme for Government³, which included the statement: “We recognise the importance of biodiversity and the complexities and challenges that tackling its loss presents. Biodiversity loss and the climate emergency are intimately bound together: nature plays a key role in defining and regulating our climate and climate is key in shaping the state of nature”.

Biodiversity is also a performance indicator in the National Performance Framework, monitoring progress towards the Environment outcome is being achieved. The National Performance Framework and the United Nations Sustainable Development Goals (SDG) share the same aims, and The First Minister committed Scotland to the Global Goals in July 2015. The SDG include climate action, life below water and life of land.

Given the pressing need to consider climate change and biodiversity loss in decisions, we believe that the statement should be strengthened by the use of the word “must” instead of “should”.

Aberdeenshire Council has a duty under part 1 the Nature Conservation (Scotland) Act 2004 to “further the conservation of biodiversity” so far as is consistent with the proper exercise of its functions. One of the policy principles set out in Scottish Planning Policy (paragraph 194) is that the planning system should seek benefits for biodiversity from new development where possible, including the restoration of degraded habitats and the avoidance of further fragmentation or isolation of habitats. Paragraph 195 of Scottish Planning Policy (SPP) states that “This duty must be reflected in development plans and development management decisions”. The production and implementation of the LDP is a key way in which Aberdeenshire Council can discharge this duty and we believe that the forward should recognise this at the start of this important document.

The suggested change would also better reflect the aims of policies in the proposed LDP which seeks to protect and enhance biodiversity, and the vision set out on p13, which seeks to promote Aberdeenshire as, “An area where natural and cultural heritage are protected and enhanced”.
