PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Section 5, page 20 National Developments, para 5.18

PROPOSED LDP TEXT: The Local Development Plan continues to recognise national developments, as identified in the National Planning Framework, and both national designated sites such as Special Areas of Conservation, Sites of Special Scientific Interest and carbon rich soils, to help conserve the best of the Aberdeenshire environment.

MODIFICATION: The Local Development Plan continues to recognise National Developments, as identified in the National Planning Framework, ~~and both national designated sites~~ **In addition, it recognises the importance of internationally and** nationally designated sites such as Special Areas of Conservation, and Sites of Special Scientific Interest and **natural resources and habitats such** as carbon rich soils, to help conserve the best of the Aberdeenshire environment.

Reason for change:

The paragraph needs to be altered to clarify that Special Areas of Conservation (SACs) are international designations rather than national. They are currently listed as an example of a national designated site, and although the national legislation is in place which protects such sites, they are international designations. Scottish Planning Policy (paragraphs 207 to 2011) defines international designations as Natura 2000 Sites, Sites designated as Special Areas of Conservation (SACs) and Special Protection Areas (SPAs) and Ramsar sites.

The modification that we would wish to see also seeks to clarify separate nature designations from the issues of National Developments, which are developments identified in National Planning Framework 3 as needed to help deliver the national spatial strategy. The purpose is not specifically to help conserve the Aberdeenshire environment, as is suggested in the current wording. We have therefore suggested that the sentence is split to help clarify the separate issues.

Although we agree that carbon rich soils are extremely important in helping meet climate change targets and are often valuable habitat, and welcome their recognition here, they are not 'designated sites' as such and we think the wording suggested, which describes them as an example of "natural resources and habitats" would help clarify this difference.
