PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

PROPOSED LDP TEXT: Each development site has been tested through a Strategic Environmental Assessment exercise and subjected to appraisal under the Habitats Regulations to ensure that the objectives of the National Performance Framework have been met.

MODIFICATION: Each development site has been tested through a Strategic Environmental Assessment exercise and subjected to appraisal under the Habitats Regulations to ensure that the LDP complies with **environmental legislation. In addition, they have been assessed to ensure that the** objectives of the National Performance Framework have been met.

Reason for change:

We believe that this paragraph must be altered to clarify why a Strategic Environmental Assessment (SEA) and Habitat Regulations Appraisal (HRA) is required. The current wording suggests that SEA and HRA are required to ensure compliance with the National Performance Framework. The requirement to undertake SEA is as result of the Environmental Assessment (Scotland) Act 2005 and requirement to undertake and a Habitat Regulations Appraisal is under The Conservation (National Habitats etc) Regulations 1994 known as the Habitats Regulations. The modification that we wish to see would clarify this. Although this may also ensure that outcomes of the National Performance Framework are met this is not the reason these specific procedures are required. We have therefore suggested that the statement regarding compliance with the objectives of the National Performance Framework are separated in another sentence.
