PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

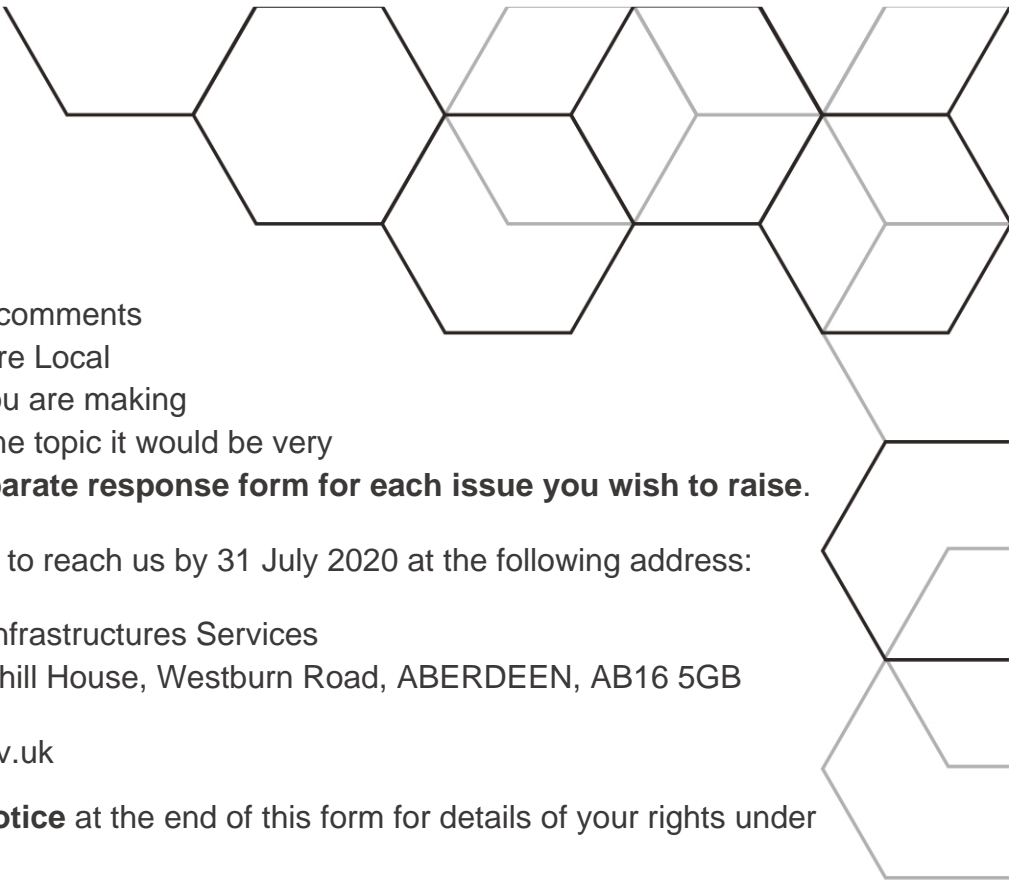

Section 6, page 27, Policy B3 Tourist Facilities, B3.3

PROPOSED LDP TEXT: We will also support shops which will act as a new tourist destination or built as an ancillary use to the tourist development. We will also support shops that plays a role in supporting the existing tourist destination and make a contribution to the development of the area. The expansion or intensification of existing retail uses in the countryside, including established farm shops, will be supported as long as the increased scale of development is appropriate to the rural character of the area. In any of these cases, the applicant will need to demonstrate that there will be no significant negative effect on existing town centres by submitting a retail impact analysis. Such development is encouraged on brownfield land where possible.

MODIFICATION: We will also support shops which will act as a new tourist destination or built as an ancillary use to the tourist development. We will also support shops that plays a role in supporting the existing tourist destination and make a contribution to the development of the area. The expansion or intensification of existing retail uses in the countryside, including established farm shops, will be supported as long as the increased scale of development is appropriate to the rural character of the area **and the proposal complies with other relevant polices in the LDP, including those which protect the natural environment and biodiversity.** In any of these cases, the applicant will need to demonstrate that there will be no significant negative effect on existing town centres by submitting a retail impact analysis. Such development is encouraged on brownfield land where possible.

Reason for change:

We recognise the important role that retail can play in tourism and the importance of this sector in the Aberdeenshire economy. In the countryside there is likely to be greater potential for impacts on natural environment, and it is crucial this is considered in addition to the character of area. We welcome the encouragement of the use of brownfield land but it should be noted that brownfield sites can be much richer and more important than greenfield sites for wildlife, notably prime agricultural land which, because it is under intensive cultivation, often has extremely low biodiversity value.

We therefore believe that the suggested wording should be included to clarify that the impacts on the environment and biodiversity will also be an important consideration. We appreciate that other policies within the Proposed LDP, particularly in Section 10 Natural Heritage and the Environment, seek to protect the environment. However, the current wording of this policy which states, "*The expansion or intensification of existing retail uses in the countryside, including established farm shops, will be supported as long as the increased scale of development is appropriate to the rural character of the area*" gives a presumption in favour of retail development in the countryside, provided it is appropriate to the rural character of the area, without caveats, apart from those relating to existing town centres.

The suggested wording recognises that other policies are likely to also be important, for instance in, section 10 Natural Heritage and the Environment and Section 14 on developer responsibilities. Without the suggested alterations, we believe this policy could allow retail developments which are damaging to Aberdeenshire's environment and run contrary other policies within the PLDP and the aims of the whole PLDP. The modification we wish to see would support retail development that compliments the aims of the LDP and protects the character and natural environment of Aberdeenshire.
