PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Section 7, page 36, Policy R3 Minerals, R3.5

PROPOSED LDP TEXT: Where appropriate we will require financial guarantees through planning conditions or Legal Agreements to ensure that a high standard of site restoration and aftercare is provided. To mitigate environmental effects of mineral development, sustainable restoration of sites to beneficial use is sought, including ecological solutions. Such work should be undertaken at the earliest opportunity. Provision will be made for the monitoring and review of such guarantees as necessary.

MODIFICATION: We believe that the words "were appropriate" should be removed so that the paragraph would read as follows:

~~Where appropriate~~ "We will require financial guarantees through planning conditions or Legal Agreements to ensure that a high standard of site restoration and aftercare is provided. To mitigate environmental effects of mineral development, sustainable restoration of sites to beneficial use is sought, including ecological solutions. Such work should be undertaken at the earliest opportunity. Provision will be made for the monitoring and review of such guarantees as necessary".

Reason for change:

We generally welcome the wording of the sections of the policy 3.5 which seek to protect the natural environment and encourage ecological solutions to site restoration. The restoration of mineral sites can play a role in helping to halt and reverse ongoing declines in biodiversity in the UK. The ‘State of Nature 2019’¹ highlights that the restoration of sand and gravel quarries has been important for increasing the extent of wetland habitats and that partnerships between conservation organisations and operating companies has helped to ensure success. Despite positive examples, it is important that the consent of mineral extraction in sensitive wildlife sites is avoided and consents are not granted that rely on complex restoration solutions as part of impact mitigation. In all cases we believe financial guarantees will be required to ensure that the agreed mitigation, site restoration or habitat enhancement is delivered, and the cost does not fall on public authorities. We cannot think of an instance when restoration is proposed and when a financial guarantee would not be required. Given that no criteria are given as to when this might be the case, it is confusing and does not give certainty to developers or the public. Therefore, we believe the words “where appropriate” should be removed.
