

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

# YOUR COMMENTS

Please provide us with your comments below. We will summarise comments and in our analysis will consider every point that is made. Once we have done this we will write back to you with Aberdeenshire Council's views on the submissions made. We will publish your name as the author of the comment, but will not make your address public.

**Modification that you wish to see** (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Tarland OP1: this is a site that was zoned for employment use in the current plan. The Local Plan Team (LPT), without consultation with the community, have rezoned this site for 10 live/work units but have not identified an alternative site in the plan for employment use, something which the community of Tarland needs.

Tarland MR071: This site was included in the current Local Development Plan for 50 houses. It has been removed from the current plan based on "marketability".

## Reason for change:

Tarland OP1: if the zoning for the live/work units is to be retained, the plan needs to include a new site for employment use. I have discussed this with the LPT and they have indicated for any new site to be included would require community consultation. It seems inequitable to me that the LPT can unilaterally rezone this site without consultation but then expecting community consultation on any new site the landowner may wish to consider. I have spoken with the LPT and it is clear, despite the zoning, that there is no guarantee that a detailed planning application will get through planning and even if it does the conditions on the planning permission may make the development of the site uneconomic. This is the likely outcome of the work the landowner is doing to develop business units at the moment; there are concerns about noise issues for adjoining housing which may be too expensive to resolve and therefore make business units uneconomic. Have the LPT assessed whether that could also be the case for live/work units?

Tarland MR071: "Marketability" appears to mean that a developer is not interested in the site. The plan process is flawed in that it does not assess the **need** for housing in communities such as Tarland. The work that the community has done has indicated that there is more than enough need to be part of the OP3 site, with houses for sale to make the site economically viable. The MR071 should be retained so that this site is available for future development and to meet additional need. New models of development need to come forward to allow housing to be provided in rural communities which developers are not interested in coming to; the recent Savills report on Rural Housing produced for the Scottish Land Commission makes it clear that there are other ways of bringing forward development that don't depend on the conventional model of development and allow the needs of a community to be met. The LDP process needs to change its way of assessment residential development so that rural communities can be sustainable rather than wither away and die.
