

## **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.


Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.





#### **SECTION RD2.14 HEALTH AND CARE FACILITIES**

#### Introduction

Dandara take issue with the requirement for developments to contribute to the delivery of healthcare facilities.

#### **Modification Required**

Paragraph 2.14 should be deleted in its entirety.

#### Justification

Dandara express concern regarding the requirement for contributions towards the provision of healthcare facilities. They consider that contributions to healthcare facilities are entirely unacceptable. Many GP practices and Dentists operate from privately owned facilities and it is entirely inappropriate to expect the development industry to fund the extension of existing privately owned premises which equates to the development industry subsidising individual businesses. In any event, healthcare is funded by Central Government through taxation and differs significantly from other locally funded infrastructure, such as roads and education. It is inappropriate that the development industry should be required to fund the provision of such facilities.
