- 2. There are ancient woodlands and protected species in the area. The environmental impact to local species that thrive in the local woodlands close to Aberdeen should be protected form development. We have been blessed to see deer, foxes, badger and birds thrive here.
- 3. Lack of infrastructure. With the recent development in the Bridge of Don (B&Q), there has been very little upgrade to the road infrastructure. There is a lack of sewage infrastructure and lack of drainage in the area. Potterton has a high water table and I have observed issues with drainage, run offs from the nearby fields causing issues.
- 4. Current demand there is very little evidence to show that such developments are in demand considering that the oil industry has been in demise since 2014 and about 70,000 people who were employed in the industry have left Aberdeen. There is evidence to show that a lot of newbuilds e.g., Stoneywood have unsold properties and for a long time the developer resorted to renting them out. With the state of the current economy and Covid I would like to challenge the demand for new developments.
- 5. Roads and infrastructure there has been very little done to the roads and infrastructure in the area of Potterton. Another large housing development will not sustain the current infrastructure.
- 6. Landscape value/character we moved to Potterton because it provided a safe haven with fields, nature and the gentleness and tranquillity of the area. A large scale development as proposed would not fit into the character of Potterton or also into the classification of a Greenbelt area.
