# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

# YOUR COMMENTS

## Reason for change:

Aberdeenshire Local outdoor access forum (ALOAF) welcomes the draft Local Development Plan and the recognition in the main plan document that walking and cycling play a potentially important role in enhancing quality of life, active travel and addressing the challenge of climate change. Unfortunately there appears to be a disconnect between these high-level objectives and the identification of opportunities or implementation of actions that would deliver the benefits outlined in the plan. It would be beneficial for the plan to recognise that 'walking and cycling' do not cover the full range of activities or people and as such the language could be interpreted as incomplete or even discriminatory.

The settlement plans do not appear to identify opportunities to enhance active travel or recreation beyond generic statements that developments may need to contribute to strategic or local transport infrastructure. It doesn't appear, for example, that the policies of 'Shaping Places' P1 and P2 are adequately translated into opportunities or actions at the settlement level and the structure of the plan does not provide space for the connectivity between settlements within and potentially between Council Areas.

The Plan needs to highlight opportunities for communities to promote the development of high quality routes that could be, for example, implemented through Developer Contributions and it needs to be recognised that funding may need to be made available to assist communities to determine the feasibility of such routes.

Specific actions that could be identified are the development of safer rural roads – where the national speed limit is incompatible with non-vehicular, but legitimate, road users. This is particularly the case where core paths have been designated on public roads. It is helpful to see core paths marked on the settlement maps, but local transport infrastructure sections in many settlement statements focus on 'footway extensions, upgrades and crossing facilities, cycle infrastructure...' rather than recognising the integral value of paths within and between settlements that may not coincide with public roads."

**As well as the established Local Rural Partnerships**, there is an increasing network of voluntary groups across Aberdeenshire that are community based, who have taken on management of local routes as well as development in some cases. These groups need to be supported by the Local Authority through the Local Development Plan as a mechanism for implementing national and local policies in a cost effective manner. These voluntary groups do

not appear to be mentioned as a potential conduit for action and the above mentioned focus on roadside access is detrimental to their efforts.
