PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

As you can see I am a resident of Deeside Brae located just off Leggart Terrace. My wife and I were attracted to purchase our retirement property at this location because it gave us what we considered to be an ideal opportunity to live on the edge of town with immediate access to historical woodland and at the same time as well as being on the edge of town ready access to local supermarkets.

We were made aware that a property company had made an application to Aberdeenshire Council for planning permission which we were very happy to hear was rejected by Aberdeenshire Council.

However, it now appears that the same property company, have made a new approach to Aberdeen City Council to build 150 homes (OP46, bid 1308 ' Leggart Brae ')

From the limited information which has been provided to date, it appears that part of their proposed development encroaches into Aberdeenshire Council's authority and is in fact green belt land.

It is surprising and to be honest more than a little upsetting that our City Council now appear to be supporting the **section** bid despite it being perfectly clear that it does not meet most of the selection criteria of Aberdeenshire Council

We would like clarification as to the thinking behind this latest approach.

Reason for change:

Again, we would like to convey our appreciation to Aberdeenshire Council to deem The Royal Devenick Park proposal by as undesirable.

Further development in this area would inevitably destroy the beautiful landscape not to mention the extensive natural habitat.

The area behind Deeside Brae () is used by many for countryside walks and never more so than in the last five months during Covid. Causeymounth which is a narrow road is also very popular with runners and cyclists and is definitely not suitable for traffic which would be coming from the proposed 150 homes.

We urge Aberdeenshire Council to maintain it's stance to uphold the important policies to keep Banchory Devenick, Aberdeenshire the fantastic place it is to live.
