

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Stonehaven and District Community Council Propose the Addition of an R2.

That a site for a Park and Ride facility similar to the "Park and Choose" at Newtonhill be reserved on the site vacated by the AWPR's Construction Team's Administration Building. The site is located to the South-West side of the AWPR Fastlink Roundabout at the junction of the B979 and the A90. The Grid Reference is:- NO 87230 87428

Reason for change:

A Park and Ride facility at this location would enable fast long-distance buses to stop with minimum delay. Most fast long-distance buses with direct connection to Edinburgh and Glasgow currently do not stop in Kincardine and Mearns.

It is envisaged that the Ury Estate in Stonehaven will eventually have a town bus service. The same service would conveniently stop at the proposed Park and Ride linking it to the town and also increase the Town Service's viability.

At present passengers accessing the Aberdeen Bus Station with cars, to connect with long-distance services, add to the City's traffic congestion. A Park and Ride at the suggested location would have immediate access from the AWPR. This would give motorists wishing to transfer to the long distance bus services a choice of avoiding city congestion and car parking fees.

The Airport Bus Service that operates via the AWPR is presently the Stagecoach 747. Its route extends from Montrose to Ellon and it would use the Park and Ride interchange. This would provide a further link to Stonehaven and allow public transport access to the long-distance buses from locations visited by its route.

The proposed Park and Ride would therefore provide a quick stopping point for long distance buses, improve the viability of Airport and Town services, and have convenient links to Stonehaven and the North. It would also reduce Aberdeen commuter traffic and the usage of the crowded City Bus Station.
