PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Include part or all of Bid site reference FR023 at Hattoncrook in Formartine.

Reason for change:

This representation adopts the Primary representation by c a s e. CONSULTING Limited regarding housing land supply in the Aberdeen HMA which indicates that the LDP has failed to identify sufficient allocations to satisfy paragraph 110 of SPP. The shortfall runs to many thousand of houses and will require the identification of numerous sites of varying sizes to resolve.

The FR023 bid anticipated an overall site capacity of 30 homes in the settlement of Hattoncrook within the Aberdeen HMA. While the settlement is quite small at around 18 houses it has the benefit of street lighting, speed limit, regular bus service to Dyce, Aberdeen and Oldmeldrum and a local shop. The level of development was considered appropriate for delivery over two phases.

In previous submissions to earlier local development plans consideration of the development potential of the location was compromised by the mistaken belief that it lay within the pipeline safety corridor and, as a consequence, residential development was not permissible.

The MIR acknowledged the advantages of the site location particularly for active travel up and down the A947 but concluded that a smaller development of approximately 8 homes would be more appropriate. That conclusion was reached, of course, without any regard to the scale of the shortfall in the allocations necessary to satisfy the provisions of paragraph 110 of SPP. It might now be the case that the entire site should be allocated to assist in resolving the substantial shortfall. Notably, the Planning Service showed no resistance to the proposal to extend the very few houses at St Katherines with an existing and proposed allocation totalling 50 houses.

In the case of the Hattoncrook site, the promoter owns substantial areas of land around the site and would have no difficulty in bringing forward a foul drainage proposal that would fully satisfy Scottish Water.

An indicative site layout indicating the first phase of the development comprising the 8 houses suggested in the MIR is attached to this representation. It clearly shows that the proposed houses are all outwith the outer limit of the pipeline corridor.

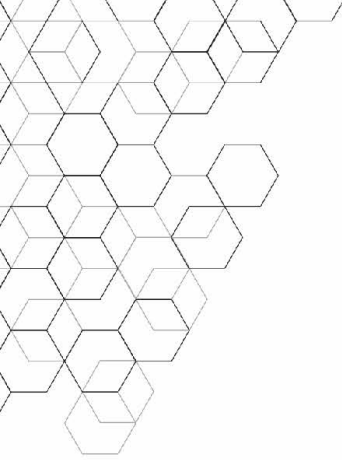

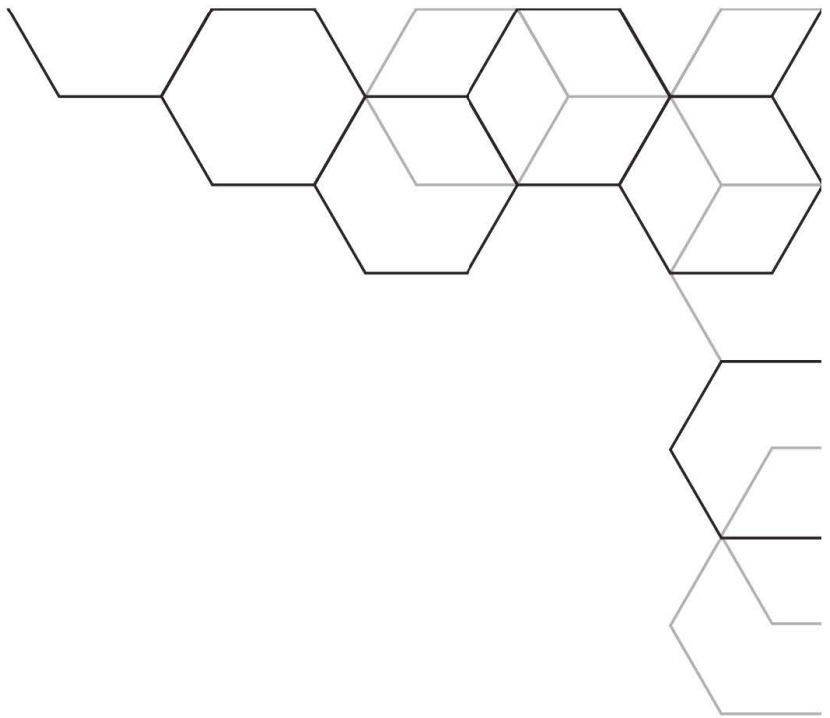

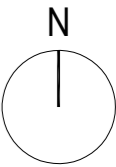
