PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Delete the contribution from the OP5 allocation in Mintlaw to meeting the strategic allowances for 2020 - 2032 (Table 3 - Housing Allocations in the Rural HMA) and identify an alternative effective allocation elsewhere in the Local Growth Area of the Rural HMA or, if marketability issues preclude the identification of a replacement effective in the Rural HMA, in the adjacent Local Growth Area of the Aberdeen HMA.

Reason for change:

The OP1 and OP2 allocations have a combined capacity of 1100 houses. The OP2 allocation has a capacity of 600 houses and commenced delivery of housing in 2014.

The 2019 housing land audit advises that in the previous five years a total of 95 houses have been completed. Anticipated completions reflect that performance and are set at 20 per annum in circumstances where no other significant site is competing for market share. Accordingly the site will be built out around 2044 assuming that the OP1 site does not depress the completion rate if and when it commences the delivery of housing in 2020. On the basis of its anticipated completion rate the site will be built out in around 2038.

These anticipated completions from the two major allocations represent the best case scenario as it remains to be seen whether demand in Mintlaw can be sustained at an average annual completion rate of 50 houses during the period to 2032.

Against this background there is little prospect of the OP5 allocation which is currently marketability constrained in the 2019 housing land audit moving into the effective supply until well after 2032.

On that basis the recruitment of a marketability constrained site from the existing established supply to contribute to meeting the strategic allowances is not warranted or competent. There is no demonstrable basis to support the confidence that this allocation will deliver housing during the plan period necessary to satisfy SPP.

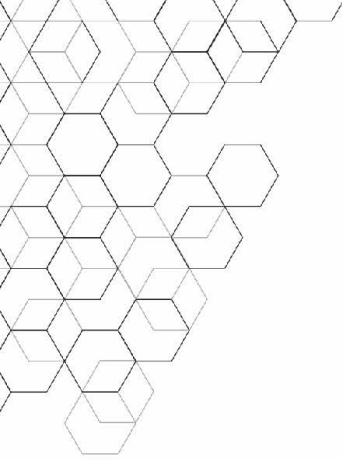
