PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Delete the OP1 allocation in Udney Station and replace it with Bid reference FR021 for 35 houses, employment land, road improvements and recreational facilities

Reason for change:

The existing OP1 allocation came into the housing land audit in 2013 and was the subject of a detailed planning application in 2017 for 25 houses. The application was refused by the Formartine Area Committee and the refusal appealed to Scottish Ministers. Scottish Ministers dismissed the appeal on the following grounds, (PPA-110-2348):

'The proposal does not, in my view, comply with the requirements of the site allocation OP1 within the Udney Settlement Statement. No link has been proposed with the adjacent Core Path, Employment land is not shown to be integrated into the design, Open space does not link with the surrounding area and in any case I have deficiency in the open space provision within the proposal. This has the effect of creating a development that would appear to be of a higher density than desired. The proposal does not meet policy P2 of the current LDP with regard to open space.'

Additionally at paragraph 26 of the Reporter's decision letter he expressed the following view:

'After my site inspection I did however have reservations on the functionality of the roads and parking layout along with the location of the road access in terms of visibility along Udney Station Road.'

A subsequent planning application by another developer was withdrawn following the submission of a neighbour representation which amplified the Reporter's concern regarding the location of the site access road. To obtain the requisite visibility splays the applicant's engineer had indicated a proposed narrowing of Udney Station Road to little more than four metres to accommodate the visibility splays. This was not obviously an acceptable proposal given that Udney Station Road is the primary access into the settlement and serves as a bus route. The site has previously been constrained in the annual audit.

Connectivity to the remainder of the settlement via Woodlea Gardens is not a possibility. Woodlea Gardens was a self build scheme built by a Limited Liability Company. There is a strip of landscaped ground between the end of Woodlea Gardens and the edge of the OP1 allocation which was still in the ownership of the Limited Liability Company when it was liquidated many years ago. Acquiring rights over such property is by no means a simple task.

In the final analysis the site is simply too small to accommodate the scheduled development and that deficiency is exacerbated by the absence of a viable access point and the unhelpful shape of the site.

A separate representation has been made in support of the inclusion of the FR021 bid site.

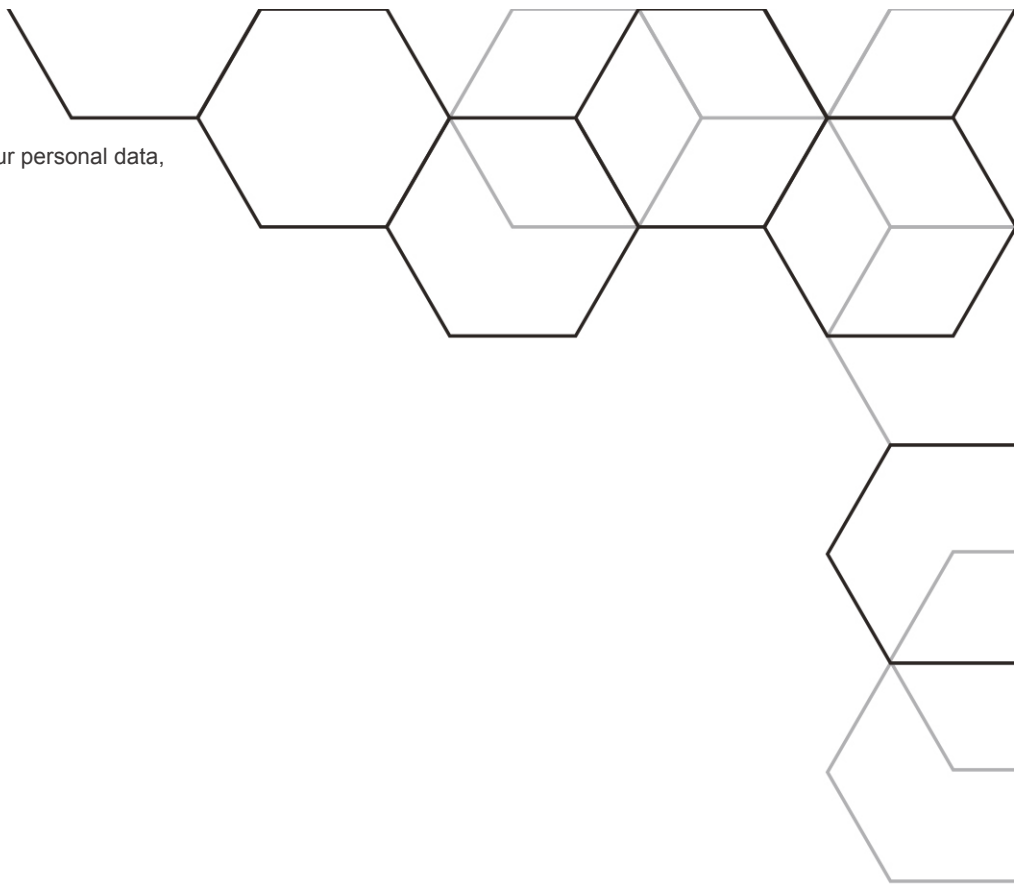

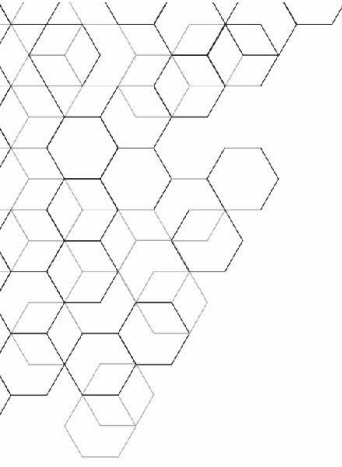
