PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

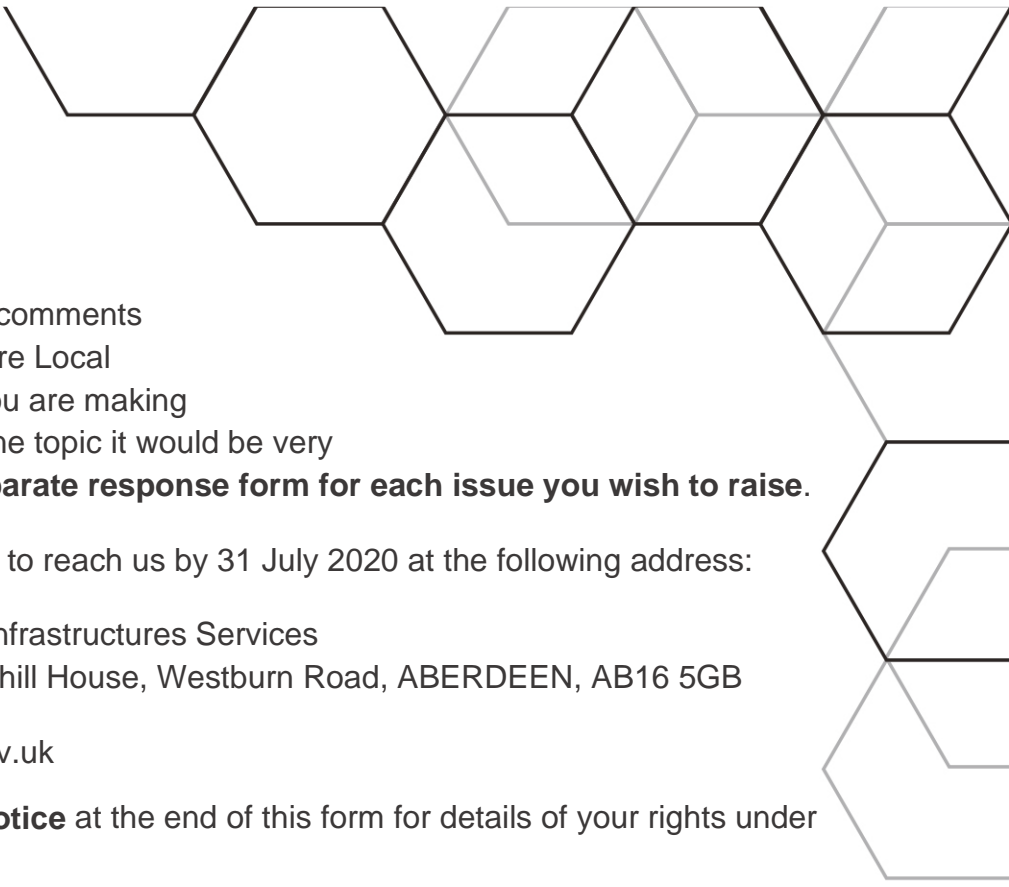

Change of access road to the OP5 development

Reason for change:

I refer to your undated letter regarding the Aberdeenshire Local Development Plan 2021 and would like to raise my objections, specifically on the OP5 development. I am a resident in St. Congan's Den in Turriff and would be directly affected by this development.

I have two issues with this development. The quadrupling of traffic from Balmellie Road through to St Congan's Den and St Congan's Circle will raise some concerning safety issues and the total disruption to the residents of St Congan's Den during the time of the building.

I would strongly argue that the present road from Balmellie Road leading to St Congan's Circle and St Congan's Den is barely adequate and safe for the 24 houses it serves at the moment. The junction separating the Den and Circle has a built in traffic slowing extension onto the road originally intended to slow the traffic to the Den. The bad design of the junction causes vehicles coming from Balmellie Road to the Den and those coming up from the Circle to drive into and through the junction on the wrong side of the road. This could lead to accidents especially with the more than doubling of traffic into the Den.

My second issue is the disruption that will be caused by the huge amount of work required to build the road into the OP5 development. As I see it the road would have to run over the burn necessitating the building of a reinforced bridge wide enough to take the two lane road and pavements. The steep bank in the field would also mean that the road would have to be built up to accommodate the rise in the land from the initial access to the height of the field. The time and transporting of extra materials and construction of this road would cause a great deal of disruption and inconvenience to the local residents. The road of course would then be used for the transporting of all the build materials of the houses over the next extended time period causing a longer disruption to the residents in the area.

The above problems could be resolved by having access to both areas of the OP5 development via the Smiddyseat Road thus negating any increase in traffic through St. Congans Den and any disruption to the residents during the construction phase.

Please take into account of my objections before finalising the plan of OP5.
